In our database, the United States came in second, behind Japan, as the country with the largest number of inadequately protected nuclear power plants....the U.S. nuclear power plants most vulnerable to inundation are the Salem and Hope Creek plants on the New Jersey/Delaware border; the Millstone plant in Connecticut; and the Seabrook plant in New Hampshire. All of these are close to large cities: The Salem and Hope Creek plants are about 90 miles from Washington and about 35 miles from Philadelphia.
